



## PRIMARY BIDS AND AWARDS COMMITTEE (PBAC) BAC Resolution No. 29 Series of 2022 SPLIT REF-033-PBD22-09

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF 103 UNITS HANDHELD GPS UNDER THE SUPPORT TO PARCELIZATION OF LANDS FOR INDIVIDUAL TITLING (SPLIT) PROJECT TO THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB), MJAZ ZENITH **TRADING** 

WHEREAS, the Department of Agrarian Reform, through a Loan from the World Bank is currently implementing the SPLIT Project and needs to procure goods for the use of its various stakeholders;

WHEREAS, on 19 November 2022, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference number 9251891, (refer to Annex "A" copy of PhilGEPs posting) as well as in the WB STEP;

WHEREAS, on 28 November 2022, two (2) bidders attended the pre-bidding conference conducted by the BAC-Primary face to face, namely: 1) MJAZ Zenith Trading, and 2) Rasa Surveying, (refer to Annex "B", bidders' attendance sheet);

WHEREAS, on 5 December 2022, Supplemental Bid Bulletin No. 1 was issued to clarify and amend certain provisions in the original bidding documents issued on November 19, 2022 (refer to Annex "C-1" copy of SBB No. 1-Amendments and Annex "C-2" Clarifications);

WHEREAS, on 12 December 2022, the deadline of submission of bids, only one bidder acquired the bidding documents, paid the bidding documents fee and submitted bid proposals. Details of bidder's submission is reflected in Annex "D" Abstract of Bids as read, and summarized below:

WHEREAS, on 13 December 2022, the BAC-TWG conducted the detailed technical evaluation of the three (3) bidders and reported to the PBAC on December 14, 2022 that the bid submission of the SCB fully complied with the requirements of the bidding documents, details of which are reflected in the detailed evaluation report (refer to Annex "E" Detailed Bid Evaluation Report of the single bidder);

WHEREAS, on 16 December 2022, the BAC-TWG conducted post-qualification evaluation of the SCB through the verification and validation of the supporting documents submitted regarding its eligibility and qualifications and reported to the PBAC on

December 19, 2022 that all documents submitted were found to be responsive to the requirements of the PBD, thus the BAC-TWG recommended to the PBAC the award for the procurement of 103 units handheld GPS to the Single Calculated and Responsive Bidder (SCRB) MJAZ Zenith Trading.

NOW THEREFORE premises considered, the PBAC resolved to adopt the recommendation of the BAC-TWG to recommend the award of contract for the procurement of 103 units handheld GPS to the SCRB, MJAZ Zenith Trading in the total contract amount of PHILIPPINE PESOS EIGHT MILLION ONE HUNDRED THIRTY SEVEN THOUSAND ONLY (PhP8,137,000.00) inclusive of all applicable taxes.
