RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF 492 UNITS COMPUTERS AND PRINTERS UNDER THE SUPPORT TO PARCELIZATION OF LANDS FOR INDIVIDUAL TITLING (SPLIT) PROJECT TO THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB), QUARTZ **BUSINESS PRODUCTS CORPORATION**

WHEREAS, the Department of Agrarian Reform, through a Loan from the World Bank is currently implementing the SPLIT Project and needs to procure goods for the use of its various stakeholders;

WHEREAS, on 17 November 2022, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference number 9231728, (refer to Annex "A" copy of PhilGEPs posting) as well as in the WB STEP;

WHEREAS, on 25 November 2022, only two (2) bidders attended the pre-bidding conference conducted by the BAC-Primary face to face, namely: 1) Tekzone Computer Sales & Services, Inc., and 2) World Solution Technology, Inc. (refer to Annex "B", bidders' attendance sheet);

WHEREAS, on 29 November 2022, Supplemental Bid Bulletin No. 1 (Clarifications and Amendments) was issued to clarify and amend certain provisions in the original bidding documents issued on November 17, 2022, and respond to queries raised by some bidders during the prebidding conference as well as written queries received (refer to Annex "C-1" copy of SBB No. 1-Amendments and Annex "C-2" SBB No. 1-Clarifications);

WHEREAS, on 07 December 2022, the deadline of submission of bids, five (5) bidders who acquired the bidding documents and paid the bidding documents fee submitted bid proposals, details of bidders'

submissions are reflected in Annex "D" Abstract of Bids as read, and summarized below:

WHEREAS, on 09 December 2022, the BAC-TWG conducted the detailed technical evaluation of the five (5) bidders and reported to the PBAC on December 12, 2022 that the bid submission of the LCB fully complied with the requirements of the bidding documents, details of which are reflected in the detailed evaluation report. On the other hand, the other LCBs likewise substantially complied with all the requirements of the PBD (refer to Annex "E" Detailed Bid Evaluation Report of the five bidders);

whereas, on 15 December 2022, the BAC-TWG conducted post-qualification evaluation of the LCB through the verification and validation of the supporting documents submitted regarding its eligibility and qualifications and reported to the PBAC that all documents submitted were found to be responsive to the requirements of the PBD, thus the BAC-TWG recommended to the PBAC the award for the procurement of 492 units computers and printers to the Lowest Calculated and Responsive Bidder (LCRB), Quartz Business Products Corporation.

NOW THEREFORE premises considered, the PBAC resolved to adopt the recommendation of the BAC-TWG to recommend the award of contract for the procurement of 492 units computers and printers in the total contract amount of **PHILIPPINE PESOS THIRTY EIGHT MILLION**

EIGHT HUNDRED SEVENTEEN THOUSAND EIGHT HUNDRED SIXTEEN ONLY (Php38,817,816.00) inclusive of all applicable taxes.
