**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE  
 PROCUREMENT OF 182 UNITS OF PROJECTORS UNDER THE SUPPORT TO  
 PARCELIZATION OF LANDS FOR INDIVIDUAL TITLING (SPLIT) PROJECT TO  
 THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB), PPAR  
 ENTERPRISES & GENERAL MERCHANDISE**

**WHEREAS**, the Department of Agrarian Reform, through a Loan from the World Bank is currently implementing the SPLIT Project and needs to procure goods for the use of its various stakeholders;

**WHEREAS**, on 30 November 2022, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference number 9297662, (refer to Annex "A" copy of PhilGEPs posting) as well as in the WB STEP;

**WHEREAS**, on 9 December 2022, two (2) bidders attended the pre-bidding conference conducted by the BAC-Primary face to face, namely: 1) AVLS Audio Visual and Lights System Corp. and 2) Cosmotech Phils. Inc. (refer to Annex "B", bidders' attendance sheet);

**WHEREAS**, on 14 December 2022, Supplemental Bid Bulletin No. 1 was issued to amend certain provisions in the original bidding documents issued on November 30, 2022 (refer to Annex "C" copy of SBB No. 1-Amendments);

**WHEREAS**, on 21 December 2022, the deadline of submission of bids, five (5) bidders who acquired the bidding documents and paid the bidding documents fee submitted bid proposals, details of bidders' submissions are reflected in Annex "D" Abstract of Bids as read, and summarized below:


**WHEREAS**, on 21 December 2022, the BAC-TWG conducted the detailed technical evaluation of the five (5) bidders and reported to the PBAC on December 21, 2022 that the bid submission of the LCB fully complied with the requirements of the bidding documents, details of which are reflected in the detailed evaluation report. On the other hand, the other LCBs likewise substantially complied with all the requirements of the PBD (refer to Annex "E" Detailed Bid Evaluation Report of the three bidders);

**WHEREAS**, on 27 December 2022, the BAC-TWG conducted post-qualification evaluation of the LCB through the verification and validation of the supporting documents submitted regarding its eligibility and qualifications and reported to the PBAC on December 28, 2022 that all documents submitted were found to be responsive to the requirements of the PBD, thus the BAC-TWG recommended to the PBAC the award for the procurement of 182 units of Projectors to the Lowest Calculated and Responsive Bidder (LCRB), PPAR Enterprises & Gen. Merchandise.


**NOW THEREFORE** premises considered, the PBAC resolved to adopt the recommendation of the BAC-TWG to recommend the award of contract for the procurement of 182 units of Projectors in the total contract amount of **PHILIPPINE PESOS SEVENTEEN MILLION FOUR HUNDRED SIXTY THOUSAND AND ONE HUNDRED SEVENTY ONLY (PhP17,460,170.00) to PPAR ENTERPRISES & GEN. MERCHANDISE** inclusive of all applicable taxes.
