## PRIMARY BIDS AND AWARDS COMMITTEE (PBAC) BAC Resolution No. <u>25</u> Series of 2022 SPLIT REF-035-A-PBD22-06

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF 50 UNITS REAL TIME KINEMATIC (RTK) UNDER THE SUPPORT TO PARCELIZATION OF LANDS FOR INDIVIDUAL TITLING (SPLIT) PROJECT TO THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB), MJAS ZENITH TRADING

WHEREAS, the Department of Agrarian Reform (DAR), through Loan No. 9141-PH with the total amount of US\$ Dollars 370.0M from the World Bank is currently implementing the SPLIT Project and needs to procure goods, one of which is the 50 units Real Time Kinematic (RTK) for the use of its various stakeholders, chargeable from the CY 2021 Unprogrammed Fund of the Department with an estimated cost of PhP100M;

WHEREAS, on 15 November 2022, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference number 9231927, (refer to Annex "A" copy of PhilGEPs posting) as well as in the WB STEP;

**WHEREAS**, on 23 November 2022, nine (9) bidders attended the pre-bidding conference conducted by the BAC-Primary face to face, namely: 1) Argotech PSI; 2) G-Surv Marketing; 3) GMI; 4) ITPI; 5) MJAS Zenith Trading; 6) Rasa Surveying Instruments; 7) Siccion Marketing Inc.; 8) Sitech Phils., Inc.; and 9) Techphil Geosolutions, Co.(refer to Annex "B", bidders' attendance sheet);

WHEREAS, on 28 November 2022, Supplemental Bid Bulletin No. 1 (Clarifications and Amendments) was issued to clarify and amend certain provisions in the original bidding documents issued on November 15, 2022, and respond to queries raised by some bidders during the prebidding conference as well as written queries received (refer to Annex "C-1" copy of SBB No. 1-Amendments and Annex "C-2" SBB No. 1-Clarifications);

WHEREAS, on 05 December 2022, the deadline of submission of bids, five (5) bidders who acquired the bidding documents and paid the

bidding documents fee submitted bid proposals, details of bidders' submissions are reflected in Annex "D" Abstract of Bids as read, and summarized below:

WHEREAS, on 06 December 2022, the BAC-TWG conducted the detailed technical evaluation of the five (5) bidders and reported to the PBAC on December 07, 2022 that the bid submission of the 1<sup>st</sup> to 4<sup>th</sup> LCB did not fully comply with the requirements of the bidding documents, details of which are reflected in the detailed evaluation report. On the other hand, the 5<sup>th</sup> LCB substantially complied with all the requirements of the PBD (refer to Annex "E" Detailed Bid Evaluation Report of the five bidders);

WHEREAS, on 12 December 2022, the BAC-TWG conducted post-qualification evaluation of the 5<sup>th</sup> LCB through the verification and validation of the supporting documents submitted regarding its eligibility and qualifications and reported to the PBAC that all documents submitted were found to be responsive to the requirements of the PBD, thus the BAC-TWG recommended to the PBAC the award for the procurement of 50 units RTK to the Lowest Calculated and Responsive Bidder (LCRB), MJAS Zenith Trading.

**NOW THEREFORE** premises considered, the PBAC resolved to adopt the recommendation of the BAC-TWG to recommend the award of contract for the procurement of 50 units RTK to MJAS Zenith Trading in

the total contract amount of PHILIPPINE PESOS NINETY TWO ONLY FIFTY **THOUSAND** FOUR HUNDRED **MILLION** (PhP92,450,000.00) inclusive of all applicable taxes.
