**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE
PROCUREMENT OF 1,324 DESKTOP COMPUTERS, PRINTERS & UPS UNDER THE
SUPPORT TO PARCELIZATION OF LANDS FOR INDIVIDUAL TITLING (SPLIT)
PROJECT TO THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB),
SILICON VALLEY COMPUTER GROUP PHILS, INC.
LOT 1- DESKTOP COMPUTERS, PRINTERS & UPS FOR LUZON**

WHEREAS, the Department of Agrarian Reform (DAR), through Loan No. 9141-PH with the total amount of US\$ Dollars 370.0M from the World Bank is currently implementing the SPLIT Project and needs to procure goods, one of which is the 1,324 Desktop Computers, Printers, & UPS for the use of its various stakeholders, chargeable from the CY 2021 Unprogrammed Fund of the Department with an estimated cost of PhP132.4M;

WHEREAS, on 24 November 2022, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPs) website with reference number 9275010, (refer to Annex "A" copy of PhilGEPs posting) as well as in the WB STEP;

WHEREAS, on 1 December 2022, seven (7) bidders attended the pre-bidding conference conducted by the BAC-Primary face to face, namely: 1) Ciudad Fil, 2) Machine & Computer World, Inc., 3) Quartz Business Products Corp., 4) Silicon Valley, 5) Tekzone Computer Sales and Services, Inc., 6) Unison Computer Systems, Inc., and 7) Xitrix Computer Corp. (refer to Annex "B", bidders' attendance sheet);

WHEREAS, on 13 December 2022, the deadline of submission of bids, three (3) bidders who acquired the bidding documents and paid the bidding documents fee submitted bid proposals for all the three (3) lots. Details of bidders' submissions are reflected in Annex "C" Abstract of Bids as read, and summarized below on a per lot basis:

WHEREAS, on 13 December 2022, the BAC-TWG conducted the detailed technical evaluation of the three (3) bidders and reported to the PBAC on December 14, 2022 that the bid submission of the LCB fully complied with the requirements of the bidding documents, details of which are reflected in the detailed evaluation report. On the other hand, the other LCBs likewise substantially complied with all the requirements of the PBD (refer to Annex "D" Detailed Bid Evaluation Report of the three bidders);

WHEREAS, on 19 December 2022, the BAC-TWG conducted post-qualification evaluation of the LCB through the verification and validation of the supporting documents submitted regarding its eligibility and qualifications and reported to the PBAC on even date


that all documents submitted were found to be responsive to the requirements of the PBD, thus the BAC-TWG recommended to the PBAC the award for the procurement of Lot 1-630 units desktop computers, printers and UPS for Luzon to the Lowest Calculated and Responsive Bidder (LCRB), Silicon Valley Computer Group Phils., Inc. .


NOW THEREFORE premises considered, the PBAC resolved to adopt the recommendation of the BAC-TWG to recommend the award of contract for the procurement of Lot 1-630 units desktop computers, printers and UPS to Silicon Valley Computer Group Phils., Inc. in the total contract amount of **PHILIPPINE PESOS FORTY SEVEN MILLION FIVE HUNDRED FORTY FOUR THOUSAND EIGHT HUNDRED FORTY ONLY (PhP47,544,840.00)** inclusive of all applicable taxes.




