	Are we required to bid for all three (3) lots?	Bidders can submit for either of the lots or all.
	Is the cost of the bidding document the same if we only bid for one lot?	Yes.
B. Section II Instruction to Bidders	How many copies of bids we needed to provide?	Each bidder needs to submit one original copy containing the first and second components of its bid; thereafter, four additional copies during post-qualification.
C. Section VII Technical Specifications	Can you provide us sample pictures of the requested items?	Sample photos cannot be provided as it may regard as tailor fitting. The technical requirements outlined in the bidding documents can be used by bidders to determine their offers.
	Junior Executive Chairs What type of material is needed? Considering that it was not specified in the technical specs.	The material is black leather as in the senior executive chair, per end-user requirement.
	Various Executive/ Conference Chairs Are colors actually distinct from one another?	Yes, since it was the preferred color of the End-Users.
	Wooden Cabinet with two swing doors Is there an existing design for wooden cabinet?	Yes. (Wooden Cabinet, 2-swing door)

The foregoing shall form an integral part of the Bid Documents and supersede previous issuances relative to the subject procurement.
