The computation required under Item b.ii is a modification of the formula for NFCC, to wit: Financial eligibility = FR – CCC Where: FR is the total current assets including any committed line of credit CCC = current value of ongoing contracts The above stated computation must be supported by the most recent Audited Financial Statement, Committed Line of Credit, if any, and a statement of ongoing contracts with supporting documents (NOA, Contract and NTP).

f) Manufacturer's Authorization

A Supplier that does not manufacture or produce the Goods it offers to supply shall submit a Manufacturer's Authorization using the form included to this RFQ ... xxx

Is it possible to submit an equivalent document other than the latter? Is a certificate of Authorized Reseller/Vendor will be sufficient?

In addition, in lieu of the Manufacturer's Authorization, we will just submit a certification from the authorized distributor because they have no office here in the Philippines.

As per previous practice, the distributor is furnishing a certificate In to the authorized reseller then Autodesk will issue a certification to the distributor that the same is the appointing distributor in the exception and philippines. Is it okay to submit a back-to-back Certification?

Though the software publisher does not have an office in the Philippines, the Procuring Entity may also accept a certificate as an authorized reseller issued by the exclusive distributor in the Philippines in favor of the prospective bidder, provided that the Certificate of Exclusive Distributorship from the software publisher in favor of the latter is also submitted

lieu of the Manufacturer's Authorization, the Procuring Entity may also accept a certificate as an authorized reseller issued by the distributor exclusive in the of Philippines in favor the prospective bidder, provided that the Certificate of Exclusive Distributorship from the software publisher in favor of the latter is also submitted.
