## BETWEEN

- the Department of Agrarian Reform, an agency of the Government of the Republic of the Philippines and having its principal place of business at Elliptical Road, Diliman, Quezon City (hereinafter called "the Purchaser"), of the one part, and
- (2) CT Citimotors, Inc., a corporation incorporated under the laws of the Republic of the Philippines and having its principal place of business at Pasong Tamo corner Don Bosco St., Makati City (hereinafter called "the Supplier"), of the other part:

  - (g) the completed Schedules (including Price Schedules)

- (i) any other document listed in GCC as forming part of the Contract
- 3. In consideration of the payments to be made by the Purchaser to the Supplier as specified in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
