WHEREAS, the Department of Agrarian Reform Central Office through a loan agreement with the World Bank intends to procure the supply and delivery of IT Equipment (531 Units Desktop Computers and 301 Units of Laptop Computers) under SPLIT-REF-066-PBD23 with a total estimated budget for the contract amounting to Php 41,599,168.00 allocated as follows:
