- c. Determine the gaps or missing links in the various policies affecting other CIAs; Identify any inconsistencies of the project safeguards instruments with relevant national laws on environmental protection, protected areas conservation and indigenous rights;
- d. Assess how the administrative orders would affect or relate to other policy issuances of DAR;
- e. Come up with policy papers and draft bills proposing new policies or necessary amendment to existing policies to further improve the implementation of the project

- 1. Minimum of 5 years of experience of the firm in conducting policy review and analysis.
- 2. Experience in the conduct of policy studies, research on agrarian reform laws and program implementation.
- 3. Experience in social and environmental assessment through actual engagement in DAR or any other government agency implementing similar land laws.
- 4. Experience in any research undertaking with foreign funding.

Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Consultant's Qualification Based Selection (CQS) method set out in the Procurement Regulations.
