WHEREAS, the Department of Agrarian Reform (DAR), intends to apply the sum of Philippine Pesos Three Million Nine Hundred Ninety-Eight Thousand Four Hundred Only (PhP 3,998,400.00) being the Approved Budget for the Contract (ABC), inclusive of taxes, to payments under the contract for the procurement of Consultancy Services (Firm) for the Establishment of Monitoring and Evaluation System for the Climate Resilient and Farm Productivity Support (CRFPS) Project.



WHEREAS, on October 01, 2024, the scheduled deadline for the submission and opening of Expression of Interest and Eligibility Documents, none were received;

WHEREAS, on the same date, the BAC Secretariat reported in the 30th Regular BAC meeting that no Expression of Interest and Eligibility Documents were received for this procurement;

NOW, THEREFORE, based on the above premises, we the members of the BAC, hereby **RESOLVE** as it is hereby **RESOLVED** to **recommend** to the HOPE the declaration of **failure of bidding** for the above-mentioned procurement activity.
